**NOTES FROM SUSAN:** Greetings, September was a busy month for me. I attended the Union of B.C. municipalities

**Islands Trust** convention and participated in several meetings with Ministers, B.C. Hydro and the ADM of MOTI. The following week we had Trust Council on Keats Island in Howe Sound. Unfortunately, eight Trustees did not attend. We did have a session on the implication of the Fresh Water Sustainability Act. We are continuing to advocate for the end of temporary freighter anchorages in the southern gulf islands, and supported the citizen climate open letter to the federal government as well as many other motions.

At our LTC meeting on Mon. Sept. 24<sup>th</sup> we heard a delegation from the LCA committee that was formed to discuss the OCP review options. I asked that the top priorities be amended to add a fresh water project. I am working towards having William Shula return in October to follow up on his fresh water workshop from earlier this year. We also had a community information meeting during our regular meeting on the subdivision bylaw. Thanks to those who attended.

# REGIONAL DIRECTOR'S NOTES

It's October! Time for harvest, Thanksgiving, Hallowe'en, and a referendum/election! It has been a great year for fruit, and I'm feeling thankful for several reasons. September was a busy month politically, with the annual Union of B.C. Municipalities (UBCM) gathering of elected official from all over the Province at the beginning, a Vancouver Island Regional Library (VIRL) Board meeting in Nanaimo in the third week, and I'm writing this on the Powell River/Comox ferry after the Regional Hospital and Regional Board meetings last night. At the UBCM I felt very thankful at the change in tone of our government. The event felt much more unified than ever in my previous experience, and when we met with Environment Minister George Heyman to plead one more time to have our waste management plan approved by his Ministry, he promised action, and it was approved within two hours! Consequently, our Regional Board meeting last night was full of motions regarding Waste Management that have been on hold for years awaiting this approval, including the plans for closing our landfill. The previous waste management committee recommended an ongoing committee to oversee this plan, and I am hustling back to Lasqueti to make their inaugural meeting this afternoon (Fri. Sept. 28<sup>th</sup>) Thanks to the volunteers Brigitte Dorner, David Ham and Dave Olsen for stepping up for this position.

It has been very interesting to see the growth of the VIRL Board in my 12 years serving on it. At the start, the meetings were very contentious, with several members getting apoplectic at the suggestion of any budget increases. Then the CAO retired, and we were very fortunate to get Rosemary Bonnano, from Ontario, to lead the staff. She started with a comprehensive review of all the properties that she presented to the Board in a very powerful and shocking powerpoint. Over the years she has revolutionized the library, built several new libraries with several more in development, built an excellent staff, with Chairs Bruce Joliffe and now Barry Avis leading the Board, and has the expenses in line so that the system can carry on thriving with only a 2% increase in funding this year (approximately .90 cents per capita). The Books By Mail service that we enjoy has matured and expanded so much, now you will find streaming Acorn TV from Britain is available through your library card. Cheaper than Netflix!

There has been lots of chatter online regarding the upcoming referendum to support the ongoing expenses of our Health Centre. It's clear that any suggestion of increased taxation rubs people the wrong way, but the actual \$ in our individual tax bills will be small for most locals. Look at all the community energy and money that went into creating this vision, even if it wasn't your vision please consider the future and vote to support the growth and maintenance of this locally created infrastructure.

I could go on, but this is long enough for one paper. Please get out and vote on the 10<sup>th</sup> (advance poll) or on the 22<sup>nd</sup> for the general election. Congratulations to Tim and Peter, our Island Trustees for the next four years, and huge thanks to Susan Morrison for the great work she has done for the Trust, wishing her more music in her retirement! ♣ On Thursday October 11<sup>th</sup> Jodi the Foot Care Nurse will be at the Health Centre from 11:00am until 3:00pm. She will be taking appointments at 30 minute intervals. The cost is \$40.00. Jodi is a self-employed foot care nurse.

She is certified to provide foot care and appropriate education to diabetics as well as persons with fungal toenails (onychomycosis) corns, calluses etc. Call her on her cell to book and appointment: 250-951-5793

In keeping with the theme of foot care I will provide a brief description of a common condition of the nails that can affect both the feet as well as hands... "nail fungus". Nail fungus is also called *onychomycosis* (on-ih-koh-my-koh-sis).

The fungal condition that infects the areas between your toes and the skin of your feet is a called athlete's foot (*tinea pedis*).

Nail fungus is common. It often begins with a white or yellow spot under the tip of a finger or toenail. As the infection goes deeper the fungus may cause the nail to discolor, thicken and crumble at the edge and can affect several nails.

In some cases, the condition may be mild and not require treatment. If it is bothersome and becomes painful and causes thickened nails, self-care steps and medication may help. Even if treatment is successful in many cases, nail fungus often comes back!

Common symptoms of nail fungus include: if one or more of your nails are thickened, has whitish to yellow-brown discoloration, brittle crumbly or ragged, distorted in shape, darkened from debris under the nails as well as slightly foul odor.

The causes of nail fungus are from fungus organisms (fungi). The most common is called dermatophyte. Nail infections can also be caused by yeast and molds.

Risk factors of nail fungal infections include age (being older). When the nail ages it becomes drier and more brittle allowing more fungi to enter. Other factors that may play a role include reduced immune system as well as decreased circulation to the feet. A history of athlete's foot, walking bare foot in communal damp areas (shower, sauna rooms, pools etc.) as well as sweating heavily.

Some preventive measures for nail fungal infections include washing your hands and feet regularly as well as washing your hands after touching an infected nail. Trim your toe nails straight across and file down thickened areas. Wear sweat absorbing socks and change them regularly. Choose shoes that breathe. Discard old shoes or treat with disinfectant or an antifungal. Wear foot wear in damp public areas. Last but not least give up those artificial nails and nail polish!Jodi may have more suggestions! The foot care clinic is Thurs. Oct. 11<sup>th</sup>.

## SCHOOL TRUSTEE'S NOTES

Summer work is over, and school has been in session for nearly a month. False Bay School received some attention this summer as did many other schools. While the provincial government is still considering the per student funding formula, they have increased funding for facilities. We've taken advantage of some of these one-time funding opportunities. We continue to slowly install more fuelefficient boilers and solar panels on our schools. This has been one of the Board's decisions and we continue to explore other options for reducing our carbon footprint.

Normally, we would be in campaign mode during October, but this time it seems we are all acclaimed! Four current Board members have run for re-election and one other person submitted nomination papers. We welcome Laura Godfrey to the Board and say farewell to Jacob Gair. Remaining on the Board are: Eve Flynn, Barry Kurland, Julie Austin and myself. I look forward to continuing to be a functional and responsive group. Eating local, in-season food is a sure way to reduce waste, packaging and to reduce our carbon footprint. Fresh food is the tastiest and the most nutritious. Fewer fossil fuel emissions are necessary. Our mild Lasqueti climate accommodates wonderful winter gardens. Leeks, parsley, arugula and kale from the gardens and apples, pears, filberts, walnuts, squash and other food go a long way towards food sustainability. For this I give thanks.

Have you washed some beans or legumes today to eat tomorrow? These dried foods store well, are a great source of protein and little packaging is needed. The carbon footprint is tiny. They cook long and slow on the wood stove. Food for thought!

Congratulations to the new members of the Lasqueti Island Solid Waste Plan Monitoring Advisory Committee (LIPMAC). Our qathet Regional District has chosen: Brigitte Dorner, David Ham and Dave Olsen. They will monitor the upgrades to the Free Store/Recycling Centre, the Landfill closure procedure and monitoring wells. Brigitte was the past secretary of the Lasqueti Island Solid Waste Management Advisory Committee. Dave Olsen was also a member. David Ham didn't miss a meeting. They are all steeped in the issues.

Further to the upgrades, there were four contractors who came to the Regional District's mandatory site visit on Sept. 7<sup>th</sup>, 2018 at the Free Store/Recycle Centre in response to the "Request for Proposals" for the build out. Stay tuned to who wins the contract.

**FREE STORE:** Open during construction. Winter hours start Oct. 1<sup>st</sup>, Thursdays only. Please remember clean, reusable clothing and household items are accepted. No: TVs, Styrofoam, batteries, electricals, electronic devices, hazardous material, and no furniture. That means no mattresses.

# **COUGAR ANNIE TALES**

Ms. Kadowskis' one-woman play about the life of west coast legend, "Cougar Annie", was inspired after she spent three years as caretaker of the legendary womans' homestead, located 33 miles northwest of Tofino, B.C.

In her play, she portrays the legendary coastal character of

Ada Annie Jordan through monologues, written letters and projected screen images. On the stage she has genuine articles; blankets, traps, furs, books, etc. that once belonged to Annie Jordan. Now and then she'll pick up her banjo and weave a song into the narrative, making the entire experience a collage of this West Coast character presented in a flowing, multi-media style. Katrina brought this play to the island in about 2013, and I have to say that I loved it then, and I'm very happy to see it again. It's great West Coast "herstory", just full of tough homesteading dialogue and anecdotes, dreams and disappointments, piss and vinegar. Kat says she's made a few changes to the original play, added some more characters and a few more music breaks. The play will run for just under an hour, then we'll have a 15 minute intermission, (with beverages and snacks available at the Cougar Bar) and then Kat and her musical cohort will transform into "The Edge Dwellers", and play a set of indie-folk genre music to cap off the evening. # COMMUNITY FORUM ON ENVIRONMENTAL STEWARDSHIP

In preparation for the Official Community Plan review, the Lasqueti Community Association is hosting a community forum to gather and consider Islander's interests regarding Environmental Stewardship and Climate Change Mitigation. This event will be held at the Community Hall on Sat. Nov.17<sup>th</sup>, from Noon-3:00pm.

The LCA community plan steering committee is seeking advance input on the current OCP from all Islanders, to be included in the Nov.17<sup>th</sup> meeting. Please write to us in advance of this date, sharing your interests and concerns regarding (but not limited to) our island's waters, shores, lands, and species. Included in this forum will be the topic of Climate Change Mitigation, or "What we could do to reduce our greenhouse gas emissions".

The current OCP Objectives related to Environmental Stewardship and Climate Change Mitigation are summarized here:

3.6 Environmental Management:

-To assist, where possible, in the establishment and maintenance of Ecological Reserves.

-To encourage that the renewable resource base is maintained in a sustainable manner.

-To encourage and promote the protection of foreshore and marine areas for public enjoyment, public access and conservation.

-To promote the preservation of fresh and salt water purity.

-To promote the retention of native flora and fauna and areas of both typical and unique ecosystems.

-To promote a safe and healthy environment for all residents.

3.9 Climate Change Mitigation

-To promote the use of renewable energy and the

development of renewable energy sources, and consider the impacts of climate change in all land use decisions; and

-To maintain Lasqueti Island's lower than Canadian average rates of greenhouse gas emissions and seek out

new means of further reducing greenhouse gas emissions through reduced fuel consumption and shifts to alternative forms of energy. While a detailed inventory is required to fully measure greenhouse gas emission rates on the Island, an aspirational target of maintaining Lasqueti Island's greenhouse gas emissions at or below 50% of the Canadian per capita average rate is set, to be -verified in 2020 and 2050.

## HOW WELL DID E-DAC SERVE OUR FIRE DEPARTMENT AND COMMUNITY?

In the Sept. issue of *Our Jste and Times*, Merrick asked "*people to reflect on how well the EDAC committee served our beleaguered dispatchers and our Fire Department.*" This is a good and relevant question and, as the former chair of the Emergency Dispatch Advisory Committee (E-DAC), I thought that it would be useful to provide some background facts and current status.

- E-DAC was created by the qathet Regional District (qRD) in early 2016 to explore, evaluate and recommend solutions for the dispatch system used by the Lasqueti Island Volunteer Fire Department (LIVFD).
- There were nine members: five were members of the LIVFD (including the Fire Chief and head dispatcher), and two were former Fire Chiefs.
- E-DAC met 18 times over 10 months, held two public forums, researched options, and contributed hundreds of hours of volunteer effort.
- The qRD provided no budget for E-DAC, and the approx. \$1,000 expenses for travel and product evaluation were covered by donations.
- E-DAC identified the values and interests of the community (from public forums), the LIVFD (from a department meeting) and qRD (from their terms for the committee).
- E-DAC spent considerable effort to design local solutions that balanced the interests of the community, LIVFD and qRD. The E-DAC evaluated and compared the current system, the North Island 9-1-1 system and three locally designed solutions.
- At the well-attended 2<sup>nd</sup> public forum, the participants were in unanimous support for a local solution (Option C). At a meeting, LIVFD dispatchers agreed unanimously to

support this option. E-DAC subsequently voted unanimously to recommend Option C.

• E-DAC delivered a comprehensive 300+ page report in Dec. 2016 that met the terms set by the qRD (see <u>http://www.e-dac.ca).</u>

The E-DAC final report included four recommendations to the Regional Board:

- (1) To support LIVFD implementing the locally-designed Option C.
- (2) To support LIVFD creating a fire dep't support committee to allow members of the public to help the LIVFD Fire Chief and dep't members.
- (3) To support LIVFD completing and deploying the Incident and Resource Locator Tool, which had such strong support that E-DAC voted unanimously that this tool should be adopted with any dispatch system.
- (4) To lobby Telus to ensure reliable telephone service.

The Fire Chief has initiated the fire department support committee. So far, it has helped with some reporting and the picnic, and it will evolve as more people volunteer to help. Further GPS data collection is being planned to advance the mapping tool, which was considered to be critical to the Lasqueti dispatch system by the expert hired by qRD to do an operational review of Option C.

After receiving the E-DAC report in Dec. 2016, the qRD Board has taken the following actions: A legal opinion. Then an operational review (that did not include a site visit to Lasqueti). Then a 2nd legal opinion (to which I was invited, but denied after I travelled to Powell River). Then a 2nd operational review by the same expert (including a site visit to Lasqueti), which resulted in a positive report on Option C. Then a 3rd legal opinion in Dec 2017.

Since Dec. 2017, there has been absolute silence on this issue from the qRD.

The E-DAC completed its term and report in Dec. 2016. The qRD has had the E-DAC report and recommendations for all of 2017 and 2018.

In my view, the members on the E-DAC provided a commendable and honourable service to our dispatchers and our Fire Department, and to the Lasqueti community as a whole, while respecting and trying to work cooperatively with the qRD. We followed an open, consultative and respectful process that treated the community, LIVFD and qRD as partners to seek solutions that best met all interests. The E-DAC demonstrated how our community can unite if a good process is followed. —Andrew Fall

# **OPINION: HEALTH CARE REFERENDUM**

Let me start this opinion piece by stating that the following is my opinion, and is in no way intended to represent the view of the Last Resort Society or its Board of Directors. That being said. I have been on the Board for seven years.

That being said, I have been on the Board for seven years. Seven years is a long stretch of chairing meetings, which at the height of construction were twice per month, and I think it is entirely fair to view the contributions of Board members as those of dedicated volunteers.

Thus, it saddens me when the Board, past or present, is represented as being somehow underhanded in our request for a tax levy. Nothing could be further from the truth. To say that a longer timeline for the decision would have been preferable, or that the Board could have done a better job communicating the reasons behind and the implications of the referendum are fair criticisms. There have been three community information meetings since the proposal was announced at the June 17<sup>th</sup> AGM, and many constructive ideas have emerged.

For the record, if this initiative does not pass, the costs of the referendum will be borne by the Regional District. A referendum on short notice seemed preferable to the other option, which would be to get a petition signed by landowners representing both 50% of the total number of parcels, and 50% of the total assessed value of all properties on the island.

While much of the public discussion has been about the total amount requested, which is up to \$45,000/year, I want to focus for a moment on what the implications are for individuals. The math is fairly simple. My property is assessed at \$125,900, so this means I would pay about \$35/year. I feel fine about making a permanent yearly donation of \$35 to keep our Health Centre operating. I did the math with a member of the Magic Mountain Co-op, and we found that each member would be paying about \$18.66/year. If you are not sure what it would cost you, I urge you to dig out your tax assessments and do the math for vourself. The ask is for \$28 per \$100,000 of assessed value. The request specifically does not include any allowance to rise with inflation, so the maximum is the maximum. The Board has committed to reviewing the levy in five years. If, after doing the math, you really feel it is unsupportable, well, there's not much I can say.

I have noticed that many of those most vocally opposed to this tax levy seem to protest that while it won't really be a financial burden on them, personally, they worry about it rising in the future, potentially harming young landowners of the future. There are many obstacles to young people living here, but the proposed tax levy will never be one of them.

Another issue frequently raised is the maintenance and administrative costs. Can they be reduced? Certainly, and there are many options that can be explored to do so. Please keep in mind that the salaries that we are currently paying are in line with wages on the island in general, and support islanders. Since the maintenance folks work on salary, and the administrator contract comes up for renewal every December, these costs are not etched in stone, and could be reduced by dedicated volunteers, who are willing and able to both to do the work, and to ensure it is done in a conscientious and timely manner. I personally don't believe that we can expect all maintenance and administrative jobs to be done by volunteers, and I think it's reasonable to pay a decent wage to those employees that our Heath Centre requires. The tax levy request is for a maximum of \$45,000, and that yearly number could be reduced if, in fact, these volunteers are willing and able.

The Judith Fisher Centre is ours, as a community. We have planned, raised the funds for construction, and built it. We own it. Countless people have donated their money, and well over \$100,000 worth of volunteer hours to reach the stage that we are at. What the tax levy referendum asks each of us is if we are willing to continue to support our own Health Centre. The costs will be borne by landowners, but will potentially benefit all residents and visitors. I feel that, as socialism goes, a local health care facility is something I can happily support, as well as easily afford. I hope the majority of voters agree.

I want to quote from the Saturna Island materials, as they are asking for a similar tax levy on their island this October. I have changed the wording, inserting the locally relevant names:

"The service is best described as a contribution service by which the qRD levies a property tax to provide secure and predictable operating funding for the Lasqueti Health Centre. The funding would be used to cover the community's portion of the funding required to operate the Lasqueti Health Centre. The tax levy funding would not subsidize services that fall under Island Health's mandate."

Many people would like to access more health services here on island, including more doctor visits and blood work, to name just two. It is my firm belief that as we push for more services from the health authority, Island Health, it would be a benefit if we can demonstrate "secure and predictable funding", to help make the case that investing time and money in more services here is viable.

This leads me to the argument that we have built a Cadillac, when perhaps we only need a Honda Civic. The important point here is that we wanted a building that would be deemed suitable to be declared a medical facility by the Health Minister, which indeed it has. Could the Civic have passed muster? Hard to say, and beside the point now. I believe that our Health Centre will be appreciated for the quality of it's construction for many years to come.

I would like to encourage any of you that are interested in our Health Centre, it's operations, or future services, to get involved. Join the Society, attend meetings, and consider putting your name forward as a member of the Board.

Finally, I want to express my deep appreciation to each and every person who has donated their time and money towards getting us to where we are today, with a Minister approved Cadillac of a building that is capable of housing many health services that many of us would like to have available on the island, and that will serve us well for many years to come. I believe that a 'yes' vote in the referendum will be something that none of us will regret, and that if enough 'yes' votes result in the establishment of the proposed tax levy, we will all benefit over the coming years. -Tim Peterson

**Resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

Non-resident property electors must produce 2 pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if there is more than one owner of the property, written consent from the majority of the property owners.

#### MAIL BALLOT VOTING

Qualified resident or non-resident property electors may vote by mail if they meet one or more of the following requirements:

- have a physical disability, illness or injury that affects their ability to vote at another voting opportunity; OR
- expect to be absent from the regional district on general voting day and at the times of all advance voting opportunities; OR
- regularly reside in any electoral area where their only access from their residence to a voting place is by boat or aircraft.
